Introduction

ICP Expert II Software is supported with Microsoft[®] Windows[®] 7 Professional operating system with Service Pack 1 and 64 bit software.

The software for the 21 CFR Part 11 version of ICP Expert II is contained on two disks:

- ICP Expert II Software
- Spectroscopy Configuration Manager (SCM)

The ICP Expert II Software disk provides the application software to run the Agilent 700 Series or Vista-PRO ICP-OES, plus the Spectroscopy Database Administrator (SDA). SDA provides a database environment to store and maintain your data. If they are not already installed on your computer, this disk will also install:

- Microsoft SQL Server 2008 R2 Express Edition
- Microsoft .Net Framework 4
- the PCI-GPIB driver
- Adobe[®] Flash Player 6 or greater

You must register the ICP Expert II Software when you first run the application.

The ICP Expert II Help provides you with information about all of the components of the software. The Help is installed automatically during the ICP Expert II software installation. It will detect the components that have been installed on your computer and install the appropriate Help topics. This is particularly useful for network environments where you may not need all Help topics.

The SCM disk provides you with a tool to manage your 21 CFR Part 11 environment. SCM provides the means to create, configure and maintain data concerning system security, user management and data paths. Privileges and Profiles controls which applications and functions may be run by a particular user. It also establishes the level of authority that a user may have with regard to signatures and accessing certain parts of an application.

Procedural Outline

With ICP Expert II Software and Spectroscopy Configuration Manager (SCM), you can perform analyses using the ICP-OES instrument in a safe and secure data storage environment that meets the requirements of 21 CFR Part 11.

The key steps to installing and setting up the software are:

- Prepare the computer:
 - Install the ICP Expert II Software
 - Complete the recommended administrative tasks such as checking SQL status, internet filtering and firewalls
- Set up databases within SDA:
 - Connect to the server
 - Set preferences
 - Create new databases
 - Create server accounts
 - Create database accounts
 - Ensure the Supplied Worksheet database is attached
- Set up SCM:
 - Set the Workstation location
 - Establish Groups
 - Establish Projects
 - Create Users and associating them to the Groups and Projects
- Start the ICP Expert II Software and complete the Software Registration

For local computer installations, where the computer controls the instrument and stores the collected data, refer to 'Scenario 1'. For network installations, refer to the appropriate 'Custom' installation in Scenarios 2 to 5. See the section 'Setup Configuration' for differences between each scenario.

Refer to the Agilent 700 Series ICP Optical Emission Spectrometers User's Guide as directed for instructions on how to install the GPIB communications device and for performing a Dark Current Scan, Wavelength Calibration and Torch Scan.

NOTE Ensure you have a clean computer that meets the operating system requirements outlined in the introduction.

Administrative Tasks

There are several settings to check before setting up SDA and SCM. These are explained below.

Microsoft Windows Operating System Updates

Perform any outstanding Microsoft Windows operating system updates before you upgrade your ICP Expert II software. Alternatively, disconnect the computer from the network before performing the upgrade.

SQL Server as an Exception

In some instances, particularly for network installations, you may need to list SQL Server as an Exception in the System and Security Center of Microsoft Windows 7. To do this:

- 1 Click Start > Control Panel > System and Security.
- 2 Select Windows Firewall.
- 3 Click Allow a program or feature through Windows Firewall.
- 4 If 'SQL Server Windows NT 64 bit' is not included in the list of Exceptions, click 'Change Settings', then click Allow another program. Browse to C:\Program Files\Microsoft SQL Server\MSSQL.10_50.SQLExpress\MSSQL\Binn and select the sqlservr application. Click Open.
- 5 Click Add.
- 6 Click OK.

Computer Power Options

To minimize the risk of data loss, ensure the Instrument Computer, Laboratory Management Computer and/or IT Server has the Hibernate or Sleep power saving mode turned off.

To do this:

- 1 Click Start > Control Panel > Hardware and Sound > Power Options.
- 2 Click Balanced (recommended).
- **3** Click Change plan settings.
- **4** Select an appropriate setting from the "Put computer to sleep" drop down menu selection. We recommend selecting **Never**.
- 5 Click Apply then OK.

Setup Configuration

This section describes five possible scenarios for setting up your instrument and supplied software. The scenario chosen depends on the desired configuration for collection of data and control of electronic records using the SCM application. The scenarios are:

installed on an IT server.	
Scenario 4	25
The ICP Expert II software and SCM are installed on the instrument computer and SDA is	
installed on an IT server.	
Scenario 5	31
The ICP Expert II software and SDA are installed on the instrument computer and SCM is	
installed on the laboratory management computer.	

The disks you will need are:

- ICP Expert II Software
- Spectroscopy Configuration Manager

The default installation folders for the ICP Expert II software are:

- C:\Program Files (x86)\Varian\ICP Expert II 7XX-ES
- C:\Program Files (x86)\Agilent\Database utilities
- C:\Program Files (x86)\Varian\21 CFR 11 (created during installation of Spectroscopy Configuration Manager disk)
- C:\Spectroscopy Databases (created during simplified or advanced setup of the database(s) from SDA)

Agilent has validated our documented installation procedure using the standard installations; therefore Agilent strongly recommends that you follow the instructions. Choose the correct procedure from the below list and then follow the instructions to install the software.

Accessing the Help

Throughout this document you are referred to the ICP Expert II Help, the SDA Help or the SCM Help for more information. To access the Help files, with the appropriate software program open, press F1 on your keyboard.

Scenario 1

Scenario 1 describes how to install all software on one computer connected to the instrument.

The following software is installed on the instrument computer:

- ICP Expert II. Includes Spectroscopy Database Administrator (SDA), Microsoft SQL Server 2008 R2 Express edition and Microsoft .Net Framework 4
- Spectroscopy Configuration Manager (SCM)
- Privileges and Profiles
- ICP Expert II Help
- NOTE Do not plug the PCI-GPIB card into the PCI slot of the controlling computer before installing the ICP Expert II Software. The card will be installed after software installation is complete. If the PC was supplied by Agilent, the PCI-GPIB card and associated software has been pre-loaded. In this case, it is not necessary to remove the card before installing the ICP Expert II Software.

To install the software:

- 1 Log on to the Instrument computer with Administrative rights.
- 2 Insert the application software disk into your DVD drive. At the AutoPlay prompt select **Run Installer.exe** and click **Yes** at the prompt.

NOTE If the AutoPlay prompt does not appear, run the 'Installer.exe' application from the DVD directory.

3 Select **File and Database** in the 'ICP Expert II Installer v2.0' window and then click **Install**.

4 Click Install Now.

If not already installed on the PC, the following components will be installed:

- NI GPIB (National Instruments GPIB Driver and Software)
- SQL Server 2008 R2 Engine
- SQL Server 2008 R2 SMO
- ICP Expert II V2.0 Application
- NOTE The installation of the Microsoft.Net framework, SQL Server 2008 R2 Engine, SQL Server 2008 R2 SMO and GPIB driver can take several minutes. Do not exit during the installation.
 - **5** If it is necessary to install the required Microsoft .NET 4.0 Framework and/or Flash player components, a window is displayed for confirmation. Click **OK** to install the required components. The Microsoft .NET 4.0 Framework may take several minutes to install.
 - 6 Follow the prompts until the 'Customer Information' window appears.
 - 7 Enter the customer information and then select the appropriate 'Install this application for:' option. Click **Next**.

- 8 Select the correct serial number type from the list. Click **Next**.
- **NOTE** The serial number for your ICP-OES instrument is located just above the peristaltic pump on the right side of the instrument.

CAUTION	You must select the correct serial number format. The CCD detector purge delay times may vary
	depending on the detector type (which is indicated by the serial number format). Damage to the
	detector may occur if the purge time is not correct.

- **9** Select the appropriate instrument model and then click **Next** in the 'Select Instrument Series' window.
- 10 Select Complete in the 'Setup Type' window and then click Next.
- 11 Click Next in the 'Destination Folder' window. To change the default installation directory, click Change to choose a different location and then click Next.

NOTE Agilent strongly recommends the Varian\ICP Expert II 7XX-ES folder and applications are installed in the recommended C:\Program Files (x86) directory.

12 Click Install.

- **13** Click **Finish** in the 'Install Completed' window. The following additional items will be installed:
 - ICP Transfer registry
 - ICP Expert II V2.0 Supplied Worksheets
 - SDA The SDAAdministrators group will also be added to the Windows User Accounts.
 - SDA Components
- NOTE The installation of the ICP Expert II V2.0 Supplied Worksheets can take several minutes. Do not exit during the installation.
 - 14 Click Next to install ICP Expert II Help and Videos.
 - 15 Click Finish once the ICP Expert II Help and Videos have been installed.
 - **16** Click **OK** at the ICP Expert II Installer V2.0 'Installation completed successfully' prompt.
 - 17 Click Cancel to exit the 'ICP Expert II Installer v2.0' window.
 - **18** Restart the computer.

To install the SCM software:

- 1 Log on to the Instrument computer with Administrative rights.
- 2 Insert the Spectroscopy Configuration Manager disk into the DVD-ROM drive. At the AutoPlay prompt select **Run Installer.exe** and click **Yes** at the prompt.

NOTE If the Autoplay prompt does not appear, run the 'Installer' application from the DVD directory.

3 Select the **ICP-OES Compliance Manager** option and then click **Install** when the 'ICP-OES CFR Expert II V2.0 Installer' window is displayed.

4 Click Install Now.

- If not already installed on the PC, the following components will be installed:
 - SQL Server 2008 R2 Engine.
 - SQL Server 2008 R2 SMO
 - ICP-OES Compliance Manager (SCM)
 - .Net Framework V4

NOTE The installation of the Microsoft SQL Server 2008 R2 Engine, SQL Server 2008 R2 SMO and .Net Framework V4 can take several minutes. Do not exit during the installation.

- **5** Follow the prompts until the 'Customer Information' window appears.
- **6** Enter the customer information, select the appropriate 'Install this application for:' option and click **Next.**
- 7 Select Complete in the 'Setup Type' window. Click Next.
- 8 Click Install.
- **9** Click **Finish** in the ICP-OES Configuration Manager Install 'Completed' window.
- **10** Click **Next** and then **Finish** to install the Help.
- **11** Click **OK** at the ICP-OES CFR Expert II V2.0 Installer "Installation completed successfully' prompt.
- 12 Select ICP-OES Privileges and Profiles option and then and then click Install.
- 13 Click Install Now.

If not already installed on the PC, the following components will be installed:

- .Net Framework V4
- ICP-OES Privileges and Profiles
- 14 Follow the prompts until the 'Customer Information' window appears.
- **15** Enter the customer information, select the appropriate 'Install this application for:' option and click **Next.**
- 16 Click Install.
- 17 Click Finish in the ICP-OES Profiles and Privileges 'Completed' window.
- **18** Click **OK** at the ICP-OES CFR Expert II V2.0 Installer 'Installation completed successfully' prompt.
- 19 Click Cancel to exit the 'ICP-OES CFR Expert II V 2.0 Installer' window.
- **20** Restart the computer.

To install the Productivity Package software:

- 1 If you are using the Productivity Package, insert the Productivity Package disk.
- 2 At the AutoPlay prompt select **Run ProductivityPackage.exe** (for SVS 1) or **Run Setup.exe** (for SVS 2) and click **Yes** at the prompt.

NOTE If the Autoplay prompt does not appear, run the 'ProductivityPackage' or 'Setup' application from the DVD directory.

3 Follow the prompts.

GPIB Communications Hardware

At the end of the application software installation, turn off the computer to install the computer-instrument interface card (if required) and to complete the automatic detection and installation of the driver for the instrument interface card. Refer to the Agilent 700 Series ICP Optical Emission Spectrometers User's Guide supplied with your instrument.

Registering and Configuring the Software

Once installation is complete, you will need to:

- Configure SDA
- Configure SCM
- Register your ICP Expert II Software
- · Perform a dark current scan, wavelength calibration and torch scan

To configure SDA:

- 1 Double-click the 'SDAdministrator' desktop shortcut, or click Start > All Programs > Agilent > Database Utilities > SDAdministrator.
- 2 Click **Yes** at the prompt.
- **3** Refer to the Help for instructions on setting up SDA.

NOTE The SDAAdministrators account must be granted access to the 'VAIM Admin' Database and any Administrators who need access to the SDA must be added to the SDA Administrators Group.

To configure SCM:

- 1 Double-click the 'Configuration Manager' desktop shortcut, or click Start > All Programs > Agilent > 21 CFR 11 > Configuration Manager.
- 2 Enter 'administrator' as the user identification and 'varian' as the password. You will be prompted to enter a new password and confirm it. Ensure that there are at least 6 characters in your new password.
- 3 Create a Station, and assign it the computer name. This can be found in Control Panel > System > Computer Name. The computer name is the full computer name, without the domain.
- 4 Create a Group, Project, User(s) and User Profile and assign them to the Station. It is recommended that the initial User Profile be set to 'Service'.

For more details on how to set up SCM, refer to the Help.

NOTE	Ensure the software registration is completed by the user of the Agilent ICP Optical Emission spectrometer. For further information refer to the Software Registration Help.
	1 Start ICP Expert II by clicking Start > All Programs > ICP Expert II > ICP Expert II.
	2 The first time the ICP Expert II software is opened a Software Registration dialog will appear. Click Next .
	3 Complete all the fields on the 'Customer Details' page. Click Next .
NOTE	The Product Key is found on the cover of the Agilent ICP Expert II software DVD case.
	4 Complete all the fields on the 'Product Details' page. Click Next .
	5 Complete all the fields on the 'Work Environment Details' page. Click Register .
	6 A dialog appears stating 'Your Agilent Software Registration has been successful' and the application will open.
NOTE	If your computer is not connected to the internet, refer to the Software Registration Help for further information.
	7 At the Log on dialog, enter the User Identification, select the desired Group and Project and then enter the password.
	Dark Current Scan, Wavelength Calibration and Torch Align
	When the software installation is complete, you <i>must</i> perform the dark current scan, wavelength calibration and torch scan before initiating any measurements with your instrument.
	These can be found on the W/L Calib and Torch Align pages of the Instrument Setup window. Refer to the Agilent 700 Series ICP Optical Emission Spectrometers User's Guide supplied with your instrument for more information.
NOTE	The worksheets used for the wavelength calibration and torch scan may need to be specified on the W/L Calib and Torch Align pages of the Instrument Setup window before proceeding. Click on the Browse button(s) on each of these pages in the Instrument Setup window and navigate to the appropriate database server and select the appropriate database worksheet.

To start and register the ICP Expert II software:

- **NOTE** If the Autoplay prompt does not appear, run the 'ProductivityPackage' or 'Setup' application from the DVD directory.
 - **3** Follow the prompts on the screen.

GPIB Communications Hardware

At the end of the application software installation, turn off the computer to install the computer-instrument interface card (if required) and to complete the automatic detection and installation of the driver for the instrument interface card. Refer to the Agilent 700 Series ICP Optical Emission Spectrometers User's Guide supplied with your instrument.

Laboratory Management Computer

To install the software:

- 1 Log on to the Laboratory Management computer with Administrative rights.

If the Autoplay prompt does not appear, browse to the DVD directory.

- **4** Select **VSDA and SQL Server Express 64 bit** and then click **Install** when the 'ICP-OES Network Database Install' window is displayed.

Upgrading Your ICP Expert II Software

This version of ICP Expert II software is only compatible with Microsoft Windows 7 Professional 64-bit (SP1) operating systems.

ICP Expert II versions 1.1 or earlier are only compatible with Microsoft Windows XP. There is no direct upgrade path from Windows XP to Windows 7; therefore there is no direct upgrade option from ICP Expert II version 1.1.5.265 or earlier to ICP Expert II version 2.0.

When upgrading from ICP Expert II version 2.0.2.275 or later there are several important points to note regarding the upgrade process:

Any previous version of ICP Expert II, SDAdministrator (formerly VSDAdministrator) and Help should be uninstalled on all systems (Instrument Computer, IT Server and Laboratory Management PC depending on the install scenario) prior to proceeding with the upgrade/installation. You do not need to uninstall the Spectroscopy Configuration Manager Software when upgrading from Software version 2.02.275 or later to version 2.0.5.283. Please follow the upgrade instructions carefully.

To uninstall software:

- 1 Click Start > Control Panel > Programs and Features.
- 2 In the 'Currently Installed Programs' list, click **ICP Expert II** and then Uninstall. Follow the prompts on the screen.

- Databases created in ICP Expert II 1.1.5.265 or earlier may need the new workspace registered before they can be used in the new version. Instructions are provided below.

To manually upgrade databases for use in the new software:

- **1** Start SDA, select the **Advanced Setup** view, and log on to the appropriate server.
- 2 Click the **Database** tab.
- **3** Ensure that the databases of interest are attached. This is done using the 'Attach' sub-tab.
- 4 Click the Upgrade sub-tab.
- **5** Any attached databases that require upgrading will automatically appear in the 'Databases' panel on the left. Select the database(s) and then click the **Upgrade** button.
- 6 When prompted, enter a reason and comment for the event log.
- 7 Register the workspace as described below.

To register the new workspace:

- 1 Select the **Advanced Setup** view in SDA and log on to the appropriate server.
- **2** Go to the **Database** tab and click the **Information** sub-tab.
- **3** Select a database.
- **4** Select the check box in the 'Unregistered workspaces' panel on the lower right (if necessary).
- **5** Click the **Register** button.
- 6 Repeat for the remaining databases.

NOTE The registration of the new workspace will not be evident until you log off from the server and log on to the server again.

Uninstalling ICP Expert II Software

If you need to completely uninstall your ICP Expert II Software and all associated software from your computer, follow these steps. This procedure includes removal of the 21 CFR Part 11 package and Microsoft SQL and Microsoft .Net Framework 2.0.

- **IMPORTANT** If you intend to reinstall the software, or install a new version, follow the uninstallation instructions in the Upgrading Your ICP Expert II Software section (see page 38). The instructions below should only be used when you want to permanently remove the software from your system.
 - **NOTE** Do not uninstall Microsoft .NET 4 or Microsoft SQL Server if they are used by other software programs on your computer, or if you want to reinstall the software.

IMPORTANT If you choose to remove Microsoft .NET 4 and Microsoft SQL Server, you must uninstall Microsoft SQL Server first. Removing Microsoft .NET 4.0 first will cause the remaining uninstall procedures to fail.

To uninstall your ICP Expert II software:

- 1 Click Start > Control Panel > Add or Remove Programs.
- **2** Click **ICP-OES Privileges and Profiles** and then **Uninstall** in the 'Currently Installed Programs' list. Follow the prompts on the screen to remove the Privileges and Profiles software.
- **3** Click **ICP-OES Configuration Manager** and then **Uninstall**. Follow the prompts on the screen.
- 4 Click ICP Expert II and then Uninstall. Follow the prompts on the screen.
- **5** Click **VSDAdministrator** or **Agilent SDAdministrator** and then **Uninstall**. Follow the prompts on the screen.
- **6** If required, click **Agilent SDA Components** and then **Uninstall**. Follow the prompts on the screen.
- 7 If required, click **ICPES Workspace** and then **Uninstall**. Follow the prompts on the screen.

	8	Click ICP Expert II Help and then Uninstall/Change . Follow the prompts on the screen.
	9	If required, click ICP Expert II VSDA Help and then Uninstall/Change . Follow the prompts on the screen.
	10	Click Spectroscopy Configuration Manager Help and then Uninstall/Change . Follow the prompts on the screen.
	11	Click Microsoft SQL Server 2008 R2 (64-bit) and then Uninstall/Change.
	12	If there are still some Microsoft SQL Server 2008 applications that have not been removed, repeat Step 10 to remove these components.
	13	Click Microsoft .Net Framework 4 Extended and then Uninstall/Change . Follow the prompts on the screen.
	14	Click Microsoft .Net Framework 4 Client Profile and then Uninstall/Change. Follow the prompts on the screen.
	15	In the list, click National Instruments Software and then Uninstall/Change . Follow the prompts on the screen to remove all National Instruments components.
	16	Delete the ICP Expert II, VSDAdministrator (If required) and 21 CFR 11 folders in C:\Program Files (x86)\Varian (the Varian folder can also be deleted if no longer required).
	17	If required, delete Database Utilities folders in the C:\Program Files (x86)\Agilent (the Agilent folder can also be deleted if no longer required).
	18	Delete the ICP Expert II folder in C:\Users\Public\Public Documents\Varian to remove all saved worksheet files, exported data, etc (the Varian folder can also be deleted if no longer required).
